Bob asked if we can transfer the USPWCD phone to Lillian's home telephone to receive the USP calls there. Once the USP Office is set up we can transfer the calls back to the office. There was discussion.

There was discussion regarding the USPWCD office space at the Big Timber Building. Bob asked if we still want to spend the yearly dollar amount for the smaller office space. There was discussion.

Bob made the motion to move towards filing a lease with the CCWCD for the USPWCD office space. Lynda seconded. All ayes carried.

C. Invoices for legal services expenses, bills needing review for payment & directors – Bob gave overview of the March 2023 bills for payment.

Dave moved to approve the invoices/bill payments for the month March 6 2023 and April 2023 director's expenses. Jon seconded. All Ayes carried.

D. Legislative Update – Dave SB#213. Most comprehensive change in land use. Completely upends what we knew about municipality control. SB#213

takes away all locally approved limits for growth. There was discussion.

This bill also includes the nullification of residential subdivision covenants. There was discussion.

There is also legislation concept that will require complete internet access to disabled people to have website accessibility. There was discussion.

#### **DISTRICT PROJECTS**

a. Jones – Jon Rice – Colin Bills / Jones Water – discussed under HASP report. Jon spoke with Allison G, USP Water Attorney. We have a meeting at the Greely Water Court on April 26<sup>th</sup>, to formulate the status conference about the Jones water court case. Matt Loose needs to fine tune his engineering report before the April meeting. There was discussion.
